**AN ORDINANCE TO AMEND CHAPTER 2 ARTICLE 5 DIVISION 1 SECTION 2-192 OF THE CITY’S CODE AS IT RELATES TO THE FISCAL ACCOUNTING PERIOD OF THE CITY**

**WHEREAS**, in May 1983, the City Council of the City of Tega Cay adopted Ordinance 13, which established the City's fiscal year as beginning on October 1 and ending on September 30 of every year;

**WHEREAS**, the fiscal years for both the State of South Carolina and York County run from July 1 through June 30, creating misalignment with the City's current fiscal calendar;

**WHEREAS**, aligning the City's fiscal year with that of the State and County would promote consistency in financial reporting, improve budget coordination, and enhance grant and funding alignment opportunities; and

**WHEREAS**, as the City’s fiscal year is being amended, the 2025/2026 fiscal accounting period shall be October 1 through June 30 the proposed amendment addresses all succeeding years.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and the City Council of the City of Tega Cay duly assembled, hereby replace Chapter 2, Article 5, Division 1, Section 2-192 of the City’s Code in its entirety with the following.

**Section 2-192.- Fiscal Accounting Period**

- a) ~~October 1 through September 30~~ July 1 through June 30 of ~~this year, and~~ each succeeding year, shall be the fiscal accounting period for the city.
