Tega Cay Beach & Swim Center Pool Guidelines

The Tega Cay Beach & Swim Center (TCBS) recognizes the value of opening the pool as a form of recreation that provides for the physical and social health of our community. Concurrently, TCBS also recognizes the continued need for additional precautions necessary to help slow the spread of COVID-19. The guidelines set forth in this document were established with the intent to balance the physical and social benefits of pool facility usage with the overall needs for public health and safety. To that end, and as with all other matters concerning COVID-19 the responsibility of slowing or stopping the advance of this disease is a responsibility shared by all, including TCBS Staff, Trident Pool Management, and pool patrons.

General Guidelines for Beach & Swim Center Patrons

- TCBS strongly encourages all members, guests and staff to wash hands as directed by SCDHEC and the CDC or use an alcohol-based hand sanitizer with at least 60% alcohol before, during and after leaving the Beach & Swim Center.
- TCBS strongly encourages everyone to practice good hygiene and follow the CDC guidelines.
- TCBS strongly encourages all patrons to check their temperature prior to arriving to the facility. If member(s) and/or guest(s) have an elevated temperature or exhibit any symptoms of COVID-19 they should not come to the facility. Guests who are ill will be asked to leave.
- TCBS strongly discourages groups and gatherings, both in and out of the water, if social distancing of at least 6 feet between people who don't live together cannot be maintained. [Exceptions include rescuing a distressed swimmer or other emergency response scenarios]

General Guidelines for Beach & Swim Center Operations

- As of our opening date of June 6, 2020, SCDHEC has informed us there are no COVID-19 limitations on the number of patrons that may be inside the pool facility. Our facility typically averages an estimated 50-75 patrons at any given time and has a capacity to have 898 total patrons per standard SCDHEC regulations based on our square footage.
- TCBS has removed all pool furniture from the pool deck until further notice. Patrons will have the option of bringing their own chair(s).
- TCBS has suspended adult lap swim lanes, morning lap swim, pool rentals and swim lessons through the month of June. TCBS will revisit these activities in July.
- TCBS with assistance from Trident Pool Management will clean and disinfect commonly used surfaces such as bathrooms, doors, handrails, ladders and gates.
- TCBS will remove from service sharable equipment such as kick boards, floats, toys.
